Group size This will depend upon the type of course.

Activities are based upon BCU Pupil: Instructor ratios and will include both practical and theoretical tuition. All courses are non-residential. A packed lunch is recommended in order to allow the potential for a full day on the water, if desired. Log books can be purchased through Grenville House if required.

Instructional staff for activities will be provided by Grenville House.

Extra - When additional services are required, other than those normally available, the full cost of these will be passed on to the group. Charges will be made for breakages/damage.

Insurance - All groups/individuals must be covered for third party claims and leaders' negligence. Grenville House cannot accept any responsibility for such claims, nor for any personal accidents or loss of property. Please ensure your insurers are informed of the activities that you intend to take part in.

Personal information - all individuals, including staff/leaders, must provide next of kin and relevant medical information prior to, or upon arrival. Grenville House Outdoor Education Centre consent forms are available if required.
